Course Overview

As cryptocurrency use becomes increasingly sophisticated, investigators must move beyond basic tracing and develop the capability to identify complex transaction patterns, laundering methodologies, and behavioural indicators across digital asset ecosystems.

The Intermediate Cryptocurrency Investigation Course is a practical 2-day intensive programme designed for researchers and investigators who already have experience investigating cryptocurrency users and transactions and now require more advanced investigative capability.

This hands-on course places learners into practical exercises from the outset, focusing on enhanced transaction tracing, wallet analysis, laundering detection, and attribution opportunities. Participants will work through realistic investigative scenarios, including a live laundering simulation exercise, to develop the confidence and technical understanding needed to investigate cryptocurrency-enabled criminality more effectively.

Who is the course for?

This course is designed for professionals who already have a foundation in cryptocurrency investigations and require enhanced operational capability, including:

- Law enforcement and financial investigators
- Financial crime and anti-money laundering (AML) specialists
- Cybercrime and ransomware investigators
- Intelligence analysts and cyber intelligence practitioners
- Corporate investigators and fraud specialists
- Compliance and regulatory enforcement teams

Participants should have completed a **Fundamentals of Cryptocurrency Investigation course** or possess equivalent practical experience.

Course Content

Final Exercise Phase

- Live Cryptocurrency Laundering Simulation
- Participants investigate funds introduced into a live system to mimic criminal laundering techniques
- Hands-On Tracing and Attribution Exercise
- Identifying movement patterns, laundering attempts, and attribution opportunities
- Debrief and Investigative Review
- Structured analysis of methodology, findings, and evidential opportunities

- Identify typologies used by offenders to disguise ownership and movement of funds

- Produce intelligence and evidential outputs suitable for operational and prosecutorial use
